1. CALL TO ORDER & DETERMINATION OF QUORUM

Mayor Vern Johnson called meeting to order at 7:00 pm.

2. PLEDGE OF ALLEGIANCE TO THE FLAG OF THE UNITED STATES OF AMERICA AND THE TEXAS FLAG

Mayor Vern Johnson lead the Pledge of Allegiance to the Flag of the United States of America and the Texas Flag

3. PUBLIC HEARING:

a) 914 Hawthorne: Violation of the Clear Lake Shores Ordinance Sec 78-16 (junk vehicles)

Building Official Kevin Harrell stated that the vehicle is out of registration, flat tires and has not moved in over 6 months and according to the city ordinance is in violation of Section 78-16 referring to junk vehicles. Letters have been sent to the property owner and the vehicle owner and neither parties have contacted the City concerning the junk vehicle.

At this time Kevin is requesting approval from City Council to create a Writ of Entry to be signed by the Judge so that he can enter the property and have the vehicle removed.

If not she will provide the location to the residents so that they can attend the meeting; will be attending the League City Chamber meeting with TxDOT and the Highway 146 expansion is to be discussed.

Mayor Johnson - stated that he is taking water pills and has lost approximately 17 lbs in one week.

City Administrator George Jones: Vandalism in the Children's Park and in the Community Garden; Street project is completed; March 8th is the next Galveston County Mayor and Council meeting in Dickinson; 3 filings turned in for the election - Mike McNamara for Mayor and Jan Bailey and Christy Lyons for City Council so we are cancelling the election.

Building Official Kevin Harrell: reported his monthly stats for the past two weeks.

Roads and Drainage: Mike McNamara reported that they have not met and are still waiting on the next street proposal.

Planning and Zoning: No report

Economic Development Corporation: Mike McNamara reported that they met last week and that the contractors for the Okie's project attended and presented preliminary plans on what is going to happen next with the project.
