Mayor Pro-Tem Amanda Fenwick made motion to accept as written Councilwoman Jan Bailey second the motion

#### Discussion:

Galveston County is allocating \$400,000 in road funds to be used as the County's share for road improvements in the City of Clear Lake Shores.

**Mayor McNamara** stated that we have property located in the City's ETJ behind Target. The road will extend from Hanson Road all the way to Hwy. 96 eventually. This will allow easier access to Kemah and to Clear Lake Shores.

Councilman Hoerner asked if this could potentially cost us \$400,000? Mayor McNamara said that the City will pay half of anything over the \$400,000 to build the road.

City Attorney Leah Hayes read the portion of the contract that explains the \$400,000 that would be the city responsibility "if" matched dollar for dollar. If any additional costs incurred the city will be responsible to provide funding or obtain funding to cover the overage.

Also, the city will be responsible for the maintenance of the road.

Councilman Hoerner asked what EDC thought about the project? Mayor McNamara said that the members were excited about it.
