All permit applications must be reviewed and approved by the Building Official.

This process could take a minimum of 1 to 3 business days.

No work shall start prior to permit being issued or you will be subjected to additional fees.

The building official may revoke this permit upon determination the the construction, erection, alteration, repair, moving, demolition, installation or replacement of the building, structure, electrical, gas, mechanical or plumbing systems for which the permit was issued is in violation or not in conformity with the provisions of the IBC code, or city ordinances, or in case there has been any false statement or misrepresentationas to the application/plan material facts on which the permit or approval was based.
