MOTION PASSED UNANIMOUS

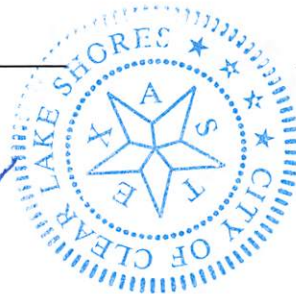
